Bleichroeder LP (Bleichroeder), an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is deemed to be the beneficial owner of 26,476,546 shares, or 13.79% of the common stock believed to be outstanding, as a result of acting as investment advisor to various clients. Clients of Bleichroeder have the right to receive and the ultimate power to direct the receipt of dividends from, or the proceeds of the sale of, such securities. 21 April Fund, Ltd. ("21 April"), a Cayman Islands company for which Bleichroeder acts as investment adviser, may be deemed to beneficially own 16,067,709 of these 26,476,546 shares, which equates to 8.37% of the Common Stock. Additionally, Bleichroeder disclaims beneficial ownership in 45,000 shares reported by Bleichroeder which are held in separate accounts managed by Michael M. Kellen in his individual capacity.
